- o I/We agree that in the event that the enrolled scholarship student and/or guardian break the terms of the contract (except in the case of previously approved and extreme extenuating circumstances), the scholarship agreement becomes void and the recipient/guardian may be held responsible for the monetary difference between the tuition for the class the scholarship student was enrolled in for the length of time he/she participated in Ballet Fantastique programs prior to terminating this contract.
